### Wallahah 2 Coal Project

The project description is provided in the Preliminary Assessment Report (PAR). A summary of it is as follows.

The Wallarah 2 Coal Project will involve the construction and operation of an underground coal mine and associated infrastructure and facilities, including:

- x extraction of up to 5 million tonnes per annum of coal by longwall method
- x coal handling and stockpiling facilities
- x a rail spur and loop off the Main Northern Railway line
- x rail loading facilities
- x administration, bathhouse and workshop buildings at Buttonderry and Tooheys Rd sites
- x a drift for mine and materials access
- x road, drainage, power, gas handling and other infrastructure works
- x water sourcing, storage, treatment and transfer arrangements according to an approved water management strategy
- x shafts and ventilation fan facilities
- x transportation of coal to market via rail
- x environmental monitoring, site landscaping and rehabilitation works

The Project Application encompasses the entire proposed mine area as shown on Figure 1 of the PAR. Project Approval is sought for the duration of 28 years within the proposed mining area.


