REPORT FROM COMMUNITY MEMBERS UPON MINISTER'S ENQUIRY	<p>Warwick O'Rourke reported he felt the Strategic Inquiry was well conducted, everyone was heard and their issues and or concerns were taken on board. Mr O'Rourke noted his appreciation for Peter Smith having provided him with a hard copy of the W2CP submission at the Inquiry hearings.</p> <p>Alan Hayes advised everyone will have 14 days right of reply from the date after all submissions appear on the Department (DOP) Website which has not occurred at this time.</p> <p>Mike Campbell confirmed he had made blunt comment regarding the DPI and their lack of Longwall Mining information being handed to this Committee, believing there is no transparency from the DPI and they fall down badly in this area. He emphasized that his comment is not a criticism of this committee.</p> <p>Peter Smith confirmed the Kores submission is on their Website and was able to hand out a hard copy of the W2CP submission to all committee members.</p>	<p>Chairman to follow up with Peter Downes from the DOP as to why the submissions do not yet appear on the website and also as to why the Chairman of this committee did not receive a copy of submissions directly from the DOP.</p>

	<p>Peter also went on to explain the steps in the overall approval process, noting how the Preliminary Assessment Report seeks comments about the project concepts and the Preliminary Risk Review, and what key issues should be focused on for the following environmental assessment report. Other formal steps and processes in the approval regime were noted, including Subsidence Management Plans, and how it requires supply of detailed information of assessments and public and government review.</p> <p>Peter also confirmed that Kores are seeking more information regarding the Community Trust and will take an opportunity at our next meeting to discuss Community Projects.</p>	<p>be enough information to make a decision whether to mine or not. Warwick O'Rourke questioned if a coal crusher would be in operation.
